Welcome

Action taken Report

The academic council reviewed the steps taken by the College regarding the suggestions offered and resolution passed in the 25th Academic Council Meeting.

The academic council had discussions on strengthening of slow learning students or slow learners of the college. Sri Shankar asked about the methodology followed to classify students as fast learners and slow learners. Dr. T.K. Umesh and Dr. G. Kotreshwar expressed their opinion for conducting more number of remedial classes for such slow learners.

Decision: Noted and Approved.

Agenda 26.4

Students' strength for the year 2017-18

The council appreciated the college for the existing student strength, especially highest admission to BA programme. The academic council also opined and expressed appreciation about the substantial admissions to PG Departments of the College when compared to PG Departments of any other College.

The council took part in the discussion on declined admission for PG Department of English of the college. Dr Syed Hajira Begum, HoD of PG Dept. English, outlined the cause of modification of eligibility criteria for admission to PG English, along with the sincere efforts put by the college to re-modify the same in

order to increase the admission. The council expressed their unhappiness on the existing eligibility criteria of 50 and 45% of marks in Bachelor's degree, for General and Category students, respectively, to get admission to PG programme in English. The council opined that the university might have fixed identical eligibility criteria for admissions of other PG programmes.

Sri. Shankar and Prof. Indumathi, suggested to include a column for sanctioned intake details in the forthcoming Academic Council meeting's notes to agenda and presentation. Prof. B. V Sambashivaiah gave details of intake, strength and percentage of admission for each programme.

Decision: Noted and Admissions have been Approved.

Sambashivaiah conveyed about the absence of such benchmarks. Dr. Kotreshwar suggested the college to include JSSCM journal of the college into UGC approved list to improve its quality. He also added his suggestion that at least an event per department of the college will be appreciable to excel their strength.

The council congratulated the college as well as, Mr. Prathap of B.Sc (CBZ), for having won the international awards with cash prize of US\$ 10,000 and for having gained other recognitions by exhibiting his talent in national and international levels. Council expressed their appreciation for the same and suggested to support such talents of the college. Prof. B.V. Sambashivaiah added the initiatives of the college about the programme "Innovated Talent Search" to the members.

The council also appreciated the continuous efforts of the college for having annual participation of NCC Cadets of the college in Republic Day Parade at New Delhi. Dr. L. Vinaykumar, Lt, has been congratulated for his capabilities and spirit of taking the responsibility and guiding cadets.

Decision: Approved


