36.4. UG and PG Admissions 2021-22

Dr. C G Betsurmath, Executive Secretary, JSS Mahavidyapeetha, Mysuru and Dr. S Srikantaswamy enquired about low admissions to B.Voc. and M.Voc. (SD), M.Com. and MA programmes. Prof. B V Sambashivaiah, Chief Excecutive, JSS College Campus, Ooty Road, Mysuru, explained the reasons to the Governing Body and clarified that majority of applicants this year have opted to take admissions to government Colleges as the admission fee in government Colleges is less compared to private Colleges. Prof. B V Sambashivaiah mentioned that less strength of B.Voc. and M.Voc. programmes, are due to outsource and nonavailability of subject teacher and the same will be taken care in future.

Dr. S Srikantaswamy sought detailed information about Kaushal Kendra grants for which Prof. B V Samabshivaiah furnished the information regarding the Kaushal Kendra grants and these are used for skill integrated scheme for M.Voc., Salary, etc.

36.8. Progress Report

Dr. S Srikantaswamy, enquired about new vocational courses. Prof. M P Vijayendra Kumar explained about introduction of B.Voc. in Digital Architecture.

Regarding the placement details, Dr. S Srikantaswamy sought clarification about less number of student placements. Prof. B V Sambashivaiah clarified that the JSS Mahavidyapeetha appointed new independent placement officer and placement will be improved in future.

Prof. K S Rangappa highlighted on less number of Ph.D., KSET, NET by the faculties of the College. He also suggested promoting full time teachers to accomplish Ph.D programme. The suggestion was well taken and will promote the faculty to pursue Ph.D. at the earliest.

Prof. K S Rangappa suggested motivating the qualified teachers from other institutions to take up research guideship in JSS Research Centre, JSS College of Arts, Commerce and Science, Mysuru under UoM. Prof. B V Sambashivaiah accepted his suggestion and will enquiry in UoM.

Regarding the publication and presentation of research papers by some faculty members, Prof. K S Rangappa and Dr. S Srikantaswamy insisted encouraging all the faculty members to do research publications. The suggestion was accepted.

Prof. K S Rangappa and Dr. S Srikantaswamy appreciated the efforts for publications from PG Department of Chemistry faculties, especially Dr. Vijendra Kumar, Asst. Professor, PG Department of Chemistry, has published in ACS publications with 6.5 impact factor.

Dr. S Srikantaswamy enquired about the incentives provided for the faculty members for publications of research papers. Prof. K S Rangappa endorsed his opinion. Prof. B V Sambashivaiah informed the Governing body that research paper publications are considered for the sanctioning of annual increment.

Prof. K S Rangappa appreciated for number of books increased during 2021-22 in the library. He enquired about major disciplines in honours. Prof. B V Sambashivaiah explained

that as per the NEP the College has introduced two major for first two years, one major for third year.

- Prof. K S Rangappa suggested including Chemistry, Biochemistry, Molecular Biology, Biotechnology as Major in B.Sc. Honours, These subjects have more scope in higher education. Prof. M P Vijayendra Kumar accepted the suggestion.
- Dr. C G Betsurmath sought clarification for quality of research is less and he advises Ph.D. is mandatory for all faculties. As it is the matter of survival, it has to be taken seriously.
- Dr. S Srikantaswamy enquired about MoUs. Prof. B V Sambashivaiah furnished details about MOUs of College with various industries.
- Dr. C G Betsurmath suggested including Radio centre programme report in future GB meetings. The suggestion was accepted.
- Dr. C G Betsurmath suggested following the alumni meeting and documenting the same scientifically. Prof. B V Sambashivaiah mentioned that, yearly two alumni meetings as going on and it will be included from next meetings.
- Sri. B Niranjanamurthy, Assistant Director, College Education Division, JSS Mahavidyapeetha, Mysuru, advised to club the students of different combinations to engage classes. Prof. M P Vijayendra Kumar accepted the suggestion.
- Dr. C G Betsurmath, sought clarification regarding BA exam in Kannada or English. Prof. B V Sambashivaiah clarified that examination of BA will held in both Kannada and English.
- Dr. C G Betsurmath enquired about the placement cell of the College and suggested to strengthen the placement activities, as the competition outside is very high. He advised to improve the smart campus facilities and activities of the competitive examination cell. Prof. B V Sambashivaiah accepted the suggestion.
