PREAMBLE

This Memorandum of Understanding (MoU) is entered into on 25-9-2022, by and between JSS College of Arts, Commerce and Science (JSSCACS), hereinafter referred to as "JSSCACS," and Chamarajanagara Milk Union Ltd (CHAMUL), hereinafter referred to as "CHAMUL."

BACKGROUND



OBJECTIVE

TERMS OF COLLABORATION

- 1. Duration:** This collaboration shall be effective from 25-9-2022 and shall remain in force for a period of FIVE YEARS, unless terminated by mutual agreement.
- 2. Students' Industry Visits:** CHAMUL agrees to facilitate and host educational visits for JSSCACS students to its facilities, providing them with practical insights into the dairy industry.
- 3. Job-Training Opportunities:** CHAMUL considers and provide job-training opportunities for JSSCACS students, subject to the availability of positions and the fulfillment of required criteria.
- 4. Academic Knowledge Transfer:** The parties may collaborate on academic initiatives, including workshops, seminars, and lectures, to facilitate the transfer of knowledge from the industry to the academic community and vice versa.
- 5. Resource Sharing:** The parties may explore opportunities for resource sharing, including expertise, research findings, and other relevant resources that contribute to the academic and practical development of students.

TERMINATION


Either party may terminate this MoU by providing written notice to the other party with 30 days prior notice.
