WHEREAS the COLLEGE is in need of software support for the Examination Management System of the COLLEGE from LOGISYS and has made detailed enquiry with regard to the software support.

AND WHEREAS, pursuant to the above, both the parties wish to record hereunder the terms and conditions of the agreement entered into between them for the Software support by the COMPANY of the requisite software for the Examinations Management System and for maintenance of the same to the COLLEGE.

NOW, THEREFORE, THIS AGREEMENT WITNESSTH AND THE PARTIES HERETO RECORD HEREUNDER THE SAID TERMS AND CONDITIONS

- The project shall be for a period of three year duration effective from 01.04.2017 to 31.03.2020.
- 2. For the first year of the project, composite sum of Rs. 1,10,000/- (Rupees one lakh ten thousand only) and applicable taxes shall be paid by the COLLEGE to the COMPANY in the manner provided hereunder, the company has undertaken to maintain the Examination Management System software comprising of the work more fully described in the SCHEDULE A hereunder
- 3. For the second year of the project, composite sum of Rs. 1,55,000/- (Rupees one lakh fifty five thousand only) (which includes AMC for the additional software supplied for the cost of 3,60,000/- during the year 2017) and applicable taxes shall be paid by the COLLEGE to the COMPANY in the manner provided hereunder, the company has undertaken to maintain the Examination Management System software comprising of the work more fully described in the SCHEDULE A hereunder
- 4. For the third year of the project, composite sum of Rs. 1,70,000/- (Rupees one lakh seventy thousand only) and applicable taxes shall be paid by the COLLEGE to the COMPANY in the manner provided hereunder, the company has undertaken to maintain the Examination Management System software comprising of the work more fully described in the SCHEDULE A hereunder

The COMPANY shall: -


- a. Maintain the software as per the specifications agreed.
- Modify the software, if required, while introducing new courses / regulations
- Extend the software support upto and inclusive of 31.03.2020.
- Support shall be provided from Bangalore through Internet

- Cease to take any responsibility regarding the development / support after the maintenance period, except for continued confidentiality of the software developed already.
- The COMPANY shall pay as penalty an amount 25% of the cost agreed upon, in case any default or damages are caused in the maintenance of accuracy, confidentiality and time schedule in the process of development and application of the said software.
- The COLLEGE is not authorized to replicate the software covered under this
 agreement at any other University / College / location
- 7. Software modification to be carried out based on the request of the COLLEGE that includes new reports / modification of existing reports, design of new marks card format, modifying exiting marks card format shall be charged separately and does not form the scope of this contract
- 8. Payment terms and conditions:
 - a) 50% of the consideration for each year shall be paid by the COLLEGE to the COMPANY on or before 30th April of every year
 - 50% of the consideration for each year shall be paid by the COLLEGE to the COMPANY on or before 31st October of every year
 - e) When the COMPANY officials visit the COLLEGE, they shall be paid an amount of Rs. 5,000/- for the first day and Rs. 3,000/- from the second day and onwards
- 9. The parties to the Agreement shall settle any dispute arising with regard to interpretation or implementation of this Agreement, through mutual consultations and agreements. In case settlement is not arrived at, the decision of Principal of the COLLEGE shall be binding on the parties to this agreement.
- 10. This agreement is subject to the jurisdiction of the courts at Mysuru / Bengaluru.

COMMERCE AND SCIENCE, a Firm/ Company/ Institution incorporated under the provisions of the Companies
Act, 1956 and having its registered office at OOTY ROAD, YELE THOTA, MYSURU - 570025 wherever applicable, and hereinafter referred to as "Corporate Customer" which expression shall, unless it be repugnant to the context
or meaning thereof, be deemed to mean and include its subsidiary, successors and assigns of the First PART;
AND
State Bank of India, a statutory corporation constituted under State Bank of India Act 1955, having its Corporate Office at Madame Cama Road, Nariman Point, Mumbai 400021 (herein after referred to as "SBI") which shall include all its successors and permitted assigns of the second PART.
WHEREAS:
A. The Corporate Customer having Khata Plus/Vyapaar/Vistaar facility wishes to offer services to its beneficiaries/users, who require transfer of funds to the account of the Corporate Customers through the State Bank Collect facility under Corporate Internet Banking and the users can generate online receipt for the funds transferred. - a. "User" shall mean any beneficiary of the Corporate Customer transferring funds using the various modes of payment to the account of Corporate Customer.
- b. "State Bank Collect Page" shall mean the page populated by the Corporate Customer for the user to furnish the details for making payment.
- c. "CINB" shall mean the Corporate Internet Banking of the Bank provided to the Corporate Customer.
- d. "Service" shall mean services offered by the Corporate Customer to Users.
- The Corporate Customer has opened a current account in SBI being Current Account No 54007362702/64083381481 at JSS COLLEGE, MYSURU Branch which account shall for the purpose of this Agreement be called the 'Collection Account' with Khata Plus/Vyapaar/Vistaar facility under Corporate Internet Banking.



Since the UUCMS portal is integrated with SSP portal, the data entry is essential for all students' scholarships.


The above information has already been shared many times in the "UOM Affiliated Colleges" WhatsApp group (Created on 04-04-2020 and there are 256 participants in the group) and reminded about the data entry process as well. The University has also informed the Principals to appoint a Technical staff in their college to look after the data entry process. The UUCMS E-Governance Cell of University of Mysore has sent the Login Credentials to the official email ID of all the colleges one month back and few colleges have already started the data entry process. In order to resolve the technical issues encountered during the data entry process. the E-Governance Cell has created one more WhasApp group by name "UOM-AAC-Nodal Officers" (Created on 02-09-2021) and it was also informed to the Principals of all the colleges one month back. So far 110 colleges have become the members of the group and all technical related issues related to UUCMS portal are shared with this group and are resolved as and when reported. We are surprised to hear that many colleges have not yet received any information about UUCMS portal and are not aware of the students' data entry process to UUCMS portal. It is also came to our notice that many colleges are not in the "UOM Affiliated Colleges" WhatsApp group and hence the above information is brought into your kind notice through this official circular and you are all requested to get the Login Credentials if not yet received and complete the data entry process as early as possible.
