The member Secretary Prof. M Mahadevappa mentioned that suggestion is in practice already.

Further, Dr. S Srikantaswamy offered the students and faculties to utilize the facilities available in the University. He enquired about the internship of the students in Industries and Prof. B V Sambashivaiah furnished details about MOUs of college with various Industries and also mentioned about Geo tag practice which was appreciated by Dr. S Srikantaswamy.

Dr. C G Betsurmath sought information on internal and external upwards movements of students in the college and suggested to insert a slide carrying the tabulated information. Dr. S Srikantaswamy suggested to motivate the students to present the papers in national and international conferences.

## D. Academic Activities of the Teachers

Prof. P Venkataramaiah suggested for separate presentation of teachers who achieve MOOC and other courses but not to include in the table of Ph D awarded teachers as Ph D is a basic qualification.

Dr. S Srikantaswamy suggested to make sure of publication of researcher papers of teachers only in the journals with DOI (Digital Object Identifier) numbers as H index of the college also need to be protected. Further he recommended to initiate add-on/certificate courses on GIS as it is the need of today.

## E. Academic Performances / Status of Teachers

Prof. Morabada Mallikarjuna and Prof. P Venkataramaiah highlighted the need for teachers to involve in interdisciplinary research and publications. Chairperson of the Committee Dr. C G Betsurmath also seconded the opinion.

Prof. B V Sambashivaiah mentioned about 18 teachers are motivated to apply for Guideship from University of Mysore.

## 32.8 Approval of results of Nov/Dec 2019 UG Examinations and Dec 2019 PG Examinations

Chairperson Dr C G Betsurmath sought justification for decreased results in UG where the PG admission is good. Joint Director Prof. R Mugeshappa cautioned about hampered admission because of decreased results. Prof. B V Sambashivaiah explained the causative factors such as low standard of students as well as less demand for certain courses. Joint Director Prof. R Mugeshappa opined that the root for issue need to identified for the wellness of the college and also felt the need for tailored syllabus to match the students from different streams. Prof. B V Sambashivaiah explained the efforts put in by the college in analyzing the situation in the interest of students as well as teachers. Dr. C G Betsurmath highlighted the need for proactive involvement of the teachers in preparing the students and also to examine the roles and responsibilities of the students and faculties in this regard.

Dr. S Srikantaswamy sought information on internal assessment and compared the same with university practices and enquired about the reasons for differences in the marks allotment. Controller of Examination Dr. B Prabhuswamy furnished the information and explained that colleges has cut off marks for pass in the internal also which is not in practice with University of Mysore. The Chief Executive of the college Prof. B V Sambashivaiah also supported the practice by mentioning that Regulations of Autonomous Colleges permits for such change. Prof. P Venkataramaiah enquired about the body which has framed the Regulations of Autonomous Colleges for which Prof. B V Sambashivaiah furnished the information.
