33.4. Approval of UG and PG Admissions 2020-21

Member Secretary Dr. H. C. Honnappa presented the details of UG and PG Admissions 2020-21. Dr. C G Betsurmath, Chairperson enquired about two combination pattern in final year BA programme. Prof. B V Sambashivaiah, Chief Executive of the College clarified that College has introduced CBCS in the year 2017-18 with two combination pattern in BA programme and was switched over to three combination pattern in the year 2018-19. So only the present final year BA students are studying 2017-18 pattern.

Prof. R. Mugeshappa, Joint Director, DCE, Mysuru Region, enquired about the validity of only six students admitted to BA (KEG) programme, Prof. B V Sambashivaiah clarified that as per the Government order the minimum admission required for BA (KEG) programme is only five.

Dr. C. G. Betsurmath enquired about low admission to UG Arts and PG English Programmes. Prof. B V Sambashivaiah, Chief Executive of the College clarified that students who have scored less than 50% of marks in English in UG programme and students who have completed PG Diploma in English are not eligible to apply PG English Programme so the number of applicants seeking admission to MA in English is less.

Dr. S. Srikantaswamy appreciated Rating/Ranking awarded to the College. Dr. C G Betsurmath suggested furnishing the details of Rating/Ranking awarded to the College, and exhibit the details in the College website.

Dr. C. G. Betsurmath suggested carrying out effective and constructive societal programmes in line with the objectives of NSS activity and encourage public participation to it. Regarding the placement details, Dr. C G Betsurmath suggested furnishing the complete details such as number of students appeared, number of students selected in the placement and the number of students opted for higher education and to work for the improvement of the placement.

Dr. C. G. Betsurmath suggested furnishing the details of total number of faculties, number of faculties with PhD qualification, number of faculties pursuing PhD, number of faculties without PhD and also suggested encouraging all the faculties without Ph.D to carryout research activities leading to PhD Degree. Prof. B V Sambashivaiah presented the details of faculties with PhD, pursing PhD and without PhD as well as the number of research scholar in the College. Dr. C. G. Betsurmath suggested encouraging the faculty members to register for PhD Programme in the College itself.

Dr. S Srikantaswamy suggested encouraging the faculty to attend refresher courses/orientation programme etc., organized by UGC - ASC. Dr. H. C. Honnappa, clarified that faculty members have been deputed for participation. Dr. S Srikantaswamy suggested to follow the UGC guidelines and Scopus to mention impact factor of research publications. Prof. B.V Sambashivaiah explained the initiatives of the college towards motivating teachers and expressed the readiness of the college to provide all the facilities to teachers to carry out research activities Prof. B. V. Sambashivaiah clarified the efforts of the College in research activities.

Dr. C G Betsurmath and Prof. Morabada Mallikarjuna highlighted the need for a greater number of teachers to carryout interdisciplinary research activities and achievements.

Regarding the details of Library information, Dr. C. G. Betsurmath suggested procuring new arrivals, useful books and to encourage faculty and students to visit library regularly and also furnish the detail the number of student and faculty visited the library.

Prof. K. S. Rangappa suggested introducing add-on courses of three months, six months, one-year, two-year duration in skill development programmes in addition to

Prof B.V. Sambashivaiah supplemented the statement

Prof B.V. Sambashivaiah also furnished the information about the skill integrated UG and PG programmes of the college, B.Voc, M Voc programmes and research activities under Kaushal Kendra, a status sanctioned by UGC and MHRD, Government of India. Further, he added that the College has been recognized as a training center under Kaushalya Karnataka Scheme to train students and youths for employment. Prof. B.V. Sambashivaiah added that the suggestions of Dr. C G Betsurmath and Prof. K. S. Rangappa are noted for needful action.

Prof. Siba Prasad Adhikary, DOS in Biotechnology, Visva Bharathi, Santiniketan, Birhum, West Bengal, appreciated the achievements of the College and complemented the College for introducing a course on physical education in UG Programme and the Open Elective course on Bio-informatics to PG Programme. Prof. Siba Prasad Adhikary, suggested faculty member to publish research papers and the college to combine both UG and PG Departments to form a single department.

Prof. R Mugeshappa suggested organising the training programmes to prepare students for placement and to the faculty members to publish research articles.

Prof. B.V Sambashivaiah furnished information about the establishment of JSS RADIO-Community Radio Station with financial assistance from JSS Mahavidyapeetha, which will be ready soon for the inauguration.

Member Secretary presented the Autonomy Grant budget for the year 2021-22

34.5. Approval for First Year PG Admissions 2020-21

Dr. H. C. Honnappa presented the details of First Year PG Admissions 2020-21. Prof. K. S. Rangappa, enquired about the excess of admissions in some PG programmes. Prof. B V Sambashivaiah clarified the excess of admissions as a supernumerary quota.

Dr. C G Betsurmath, Chairperson enquired about low admissions to PG Kannada, English, M.Com and M.Voc Programmes. Dr. H C Honnappa explained the reasons to the Governing Body and clarified that the number of applications received for admission to PG Commerce programme by the University of Mysore for this academic year were only 2400 instead of around 5000 applications every year. Prof. B V Sambashivaiah clarified that majority of applicants this year have opted to take admissions to government Colleges as the admission fee in government Colleges is less compared to private Colleges. Prof. K. S. Rangappa seconded and appreciated the admissions to Science subjects of Postgraduate level.

Prof. R Mugeshappa suggested organising placement training programmes.

Dr. C G Betsurmath suggested organising coaching classes for NET/KSET examinations availing the services of expert faculty of the College and also suggested to provide admission details inclusive of previous year.

Prof. Morabada Mallikarjuna suggested the PG Departments with low admissions to take appropriate measures to improve admissions in the coming years.

34.6. Approval for Introduction of B.Voc in Digital Architecture and MCA

Dr. C G Betsurmath enquired about the new programmes, B.Voc. in Digital Architecture and MCA. Prof. B V Sambashivaiah explained the demand and the necessity for the introduction of the new programmes. He also clarified that the Curriculum (syllabus) structure of B.Voc in Digital Architecture programme has two components 40% of General Education Component (GEC) and 60 % of Skill Development Component (SDC). The teaching and evaluation of 40% of GEC can be taken care off by the College and the 60 % of SDC will be taken care off as per NSDC.

Prof. K. S. Rangappa has endorsed the demand for admission to MCA programme. Dr. S Srikantaswamy enquired about eligibility criteria for B.Voc. in Digital Architecture programme. Prof. B V Sambashivaiah said that, candidates with PU / +2 under skill stream are eligible for direct admission and for candidates with PU / +2 under regular stream, a six month bridge course Level 4 training programme will be conducted to get eligibility for admission.

Prof. B V Sambashivaiah concluded that these interdisciplinary programmes are being introduced as per the guidelines of NEP 2020.

Dr. C G Betsurmath suggested to study the impacts of the NSS activities and prepare a report on it. Dr. S. Srikantaswamy enquired about the village adoption and awareness creation programme. Prof. B V Sambashivaiah clarified the extension activities carried out in the programmes.

Regarding the placement details, Dr. C G Betsurmath enquired about less number of student placements and suggested organising special lectures by experts to enhance placement opportunities and employability of students. Regarding the appointment of independent Placement officer, Prof. B V Sambashivaiah clarified that the College has submitted a proposal to JSS Mahavidyapeetha for the appointment.

Prof. R Mugeshappa suggested organising training programmes to students to enhance employability of the students. Dr. S Srikantaswamy appreciated the number of students cleared KSET examination.
