Prof. K S Rangappa suggested to organize Orientation Programme for research scholars and also suggested to encourage the faculty members of other JSS institutions with Ph.D. degree to apply for Guideship through College Research Centre.

Sri B Niranjana Murthy informed that faculties of other JSS institutions with Ph.D. degree are not eligible to apply for research guideship through College Research Centre as per the regulations of University of Mysore.

Dr. S Srikantaswamy enquired about availability of infrastructure in the PG Department of Zoology for the introduction of Ph.D. Programme. Further, he suggested that faculty of PG Department of Zoology with Ph.D. degree can apply for Guideship for Ph.D. in Genetics.

Using this provision and the directions of NEP – 2020 that Teacher Education Programme be introduced in Multidisciplinary Institutions, the College proposes to introduce Four Year Integrated Teacher Education programme. Further, the details of the said programme including Diploma in Dance & Music are given in Annexure A.


