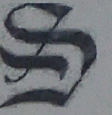




MEMORANDUM OF UNDERSTANDING (MoU)

4. **Confidentiality:** Both Parties agree to maintain the confidentiality of any proprietary information disclosed during the collaboration.


5. **Miscellaneous:**

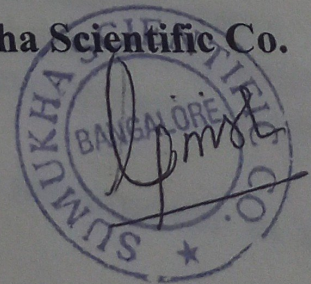
