

# for facilitating Students' Training/Postgraduate Research/ R & D

This Memorandum of Understanding (hereinafter referred to as MoU) is made on this 17<sup>th</sup> day of February 2020 by and between the University of Horticultural Sciences, having its Udyanagiri, Near Seemekeri Cross, Hubli Bypass Road, Navanagar, Bagalkot - 587104, Karnataka [hereinafter called "UHS-B"/First party], a public university exclusively dedicated to the study and research of Horticultural Sciences established by the Government of Karnataka on the ONE PART and JSS College of Arts, Commerce and Science, Ooty Road, Mysuru - 570025, having its headquarters at Mysore [hereinafter called "JSS College"/Second party] on the OTHER PART (who for the purpose of this MoU are hereinafter collectively referred to as the parties).

The parties, having discussed fields of common research interests and allied activities between the two institutions, have decided to enter into long-term collaboration for promotion of students' training, quality postgraduate research and R & D work in cutting edge areas.

WHEREAS the "First Party" established vide Karnataka Act No 11 of 2010 the University of Horticultural Sciences Act, 2009, is involved in the Education, Research and Extension of horticultural crops AND WHEREAS the "Second Party", established vide Reg. No. 12/1962-63/Mysore dated 17-07-1962 by Govt. of Karnataka and recognized by University Grants Commission - Recognition No: F.1-1/2004(CPP-1) at its Postgraduate, Department of Biotechnology is involved in plant biotechnology and animal biotechnology research - to be specific phytochemistry, cancer biology, rDNA technology, vector biology, etc.

AND WHEREAS it has been considered expedient to agree in writing to participate jointly in the projects requiring expertise and logistics from both the parties.

Article 1. Scope

The Second party will recognize the First party as an Institute for conducting research related to the internship/thesis requirement of the research students for M.Sc., Biotechnology and Ph.D. degrees, The Second party will recognize Scientists of the UHS-B as recommended by its Vice-Chancellor in accordance with the University rules and regulations for guiding students working for the said degrees. Operational details of research effort and collaboration will be made in common research programmes and/or projects restricted to specific mandated domain within the approved disciplines/divisions of UHS-B.

Ooty Road, MYSURU-25, Page 2 or 5 Research instrumentation facility and library facilities available with the First party and the Second party will be made available to the faculty and research scholars. However, the costs of specific consumables will be borne by the respective organizations.

There shall be an exchange of students for research and training purposes. Accommodation in the Hostel / Quarters shall be arranged, subject to availability, as per extant rates. In the event of non-availability for any reason, the students will have to make their own arrangements for boarding and lodging. The duration of exchange visits will be determined by mutual consent between both the parties.

#### Article 2. Management

Vice-Chancellor/Registrar of the First party and the Head of the Institution of the Second party - Principal will be responsible to work out operational details of cooperation between the two organizations and ensure proper and effective implementation of this MoU.

#### Article 3. Exchange of Information

The term "information" includes scientific or technical data, results and/or methods of investigation, and other information intended to be provided, exchanged, or arising under project descriptions entered into pursuant to this MoU.

The parties support the widest possible dissemination of information. Each party in joint projects shall be given the right to use, disclose, publish or disseminate such information for any and all purposes.

#### Article 4. General Provisions

It is understood that the First party and the Second party subscribe to the principle of equal opportunity and do not discriminate on the basis of race, sex, age, caste or religion. Both the Institutions shall abide by these principles in the administration of this agreement and neither party shall impose criteria for exchange of scholars or students, which violate principles of non-discrimination.

Both parties understand that all financial agreements will have to be negotiated separately.

Both parties acknowledge that exchange of students from one party to the other shall be subject to the availability of funds and shall comply with the regulations and policies of the First party and the Second party.

Any research publications arising will be jointly published.

A copy of the dissertation will be submitted to first party after award of the degree by second party.

All questions related to this MoU arising during its term will be settled by the parties by mutual agreement. Disagreements at the operating level shall be forwarded to respective higher officials for appropriate resolution failing which an arbitrator of mutual acceptance may be identified for the settlement of dispute, if any.

All questions not foreseen related to this MoU will be handled by the parties by mutual agreement.

Nothing in this MoU is intended to affect other cooperation or collaborations between the parties.

#### Article 5. Admission

All those who wish to register as trainees or for Master/Doctoral programme under this MoU must have taken admission at the First Party or at the Second party. Admission of the students and the award of degrees for different programmes will be the responsibility of the First party or the Second party as per the rules and regulations of their own.

Allotment of the students at the First party will be done by the approval of Vice-chancellor of the First party and Principal/Head of the Department of the Second party.

Both the parties would have the right to screen the student's eligibility for training based on their academic performance.

The number of student(s) at any particular time will be subjected to the availability of research facilities and scientists' time to guide thesis research at each institution.

Any student(s) admitted to the First party/Second party for training/postgraduate research, if found violating the rules and regulations laid down by the each parties or indulge in such activities that amount to tarnishing the image of the Institute, or cause damage to the property, the registration of such student(s) would be summarily terminated. Both the parties will not complete the formalities of issuing the certificates to such students until they compensate the losses to the First party.

Article 6. Entry into effect, modification and termination

This MoU shall become effective on the date it is signed by the parties and shall be valid for three years at the first instance. The period of validity of this MoU may be extended by mutual consent up to five years. Both parties shall review the status of

the MoU at the end of each three/five year period to determine any modification, whenever necessary. This MoU may be amended by mutual written agreement and may be terminated at any time by either party upon written notification signed by the competent authority of the party initiating termination. Such notification must be given to the other party at least six months in advance from the effective date of termination.

All joint activities not completed at the expiration or termination of the MoU may be continued until their completion under the terms of this MoU.

No amendment or modification of the MoU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be amendment of the MoU. The modifications/ changes shall become part of the MoU and shall be effective from the date on which they are made/executed, unless otherwise agreed to.

This MoU has been executed in two originals, one of which has been retained by the First party and the other by the Second party).
