for the purpose of Academic Cooperation



The aim of the Memorandum of Understanding shall be to achieve a broad balance in the respective contributions and benefits of the collaboration, and this shall be subject to periodic review by both the organizations.

The two organizations agree to assist in the seeking of appropriate work space, library and technical facilities as appropriate.

In the implementation of specific cooperative programs, a written agreement covering all relevant aspects including funding and the obligations to be undertaken by each party will be negotiated, mutually agreed and formalized in writing, prior to the commencement of the program.

This agreement will take effect from the date of its signing and shall be valid for a period of FIVE years from that date unless sooner terminated, revoked OR modified by mutual written agreement between the Parties, and may be extended by mutual written agreement.

Either party may terminate the agreement at any time during the term by the provision of three months written notice to the other party.





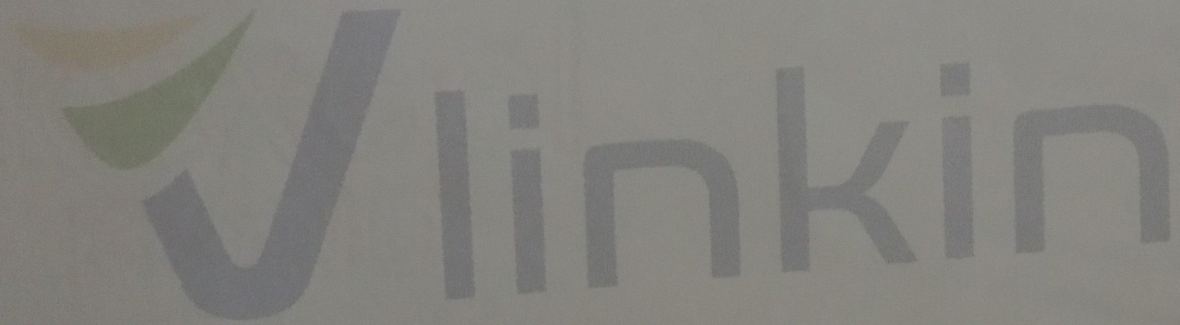
