a) Introduction.

The accounts of Principal, JSS Arts, Science & Commerce College, Ooty Road, Mysuru for the year 1998-99 to 2007-08 was audited during March/2009. Actions taken on the outstanding paragraphs of the previous inspection report were verified and the paragraph which could not be treated as settled are brought out in this part of the report.

Short remittance of tuition fee and laboratory fees to Joint Account Rs.560316/-.

Current Audit:

During current audit, the accounts of the Principals, JSS Arts, Science & Commerce College, Ooty Road, Mysuru for the years 2008-09 to 2016-17 was test checked besides conducting a general review of all the records produced to audit. Important points are detailed in this part of the report.

I. Delay in submission of tuition fee & Lab. Fees Rs.28.96 lakh.

The Government of Karnataka vide its Gazette Notification No ED 139 UPC 2014, Bengaluru dated 25.09.2014 had directed the Private Aided Colleges that the Management Committee shall credit one rate of standard fee out of two collected under sub rule (1) to Joint account and another rate of standard fees collected may be credited to the college account and this amount must be utilized for the benefit of students and college development purpose only. The management shall furnish and also authorize the bank to furnish monthly statement of the college account to the Director. The amount accumulated in Joint account shall be utilized for payment of salary, arrears or for any other purposes authorized by the Government. The principal would remit part of standard fees collected to the joint account on the same say. The above order was not applicable for girl students in respect of who were exempted from payment of tuition and lab Fees.

On review of records, it was noticed that the management had collected tuition fees & lab.fees from students and had remitted it to joint account on a later date as mentioned above. In contrary to the notification issued by Government of Karnataka, it was seen that the fee collected was kept in college bank account till its remittance and the details are as follows.
